## General remark - BBVA acting as Systematic Internaliser in the EU

Banco Bilbao Vizcaya Argentaria, S.A. (BBVA) will act as Systematic Internaliser (SI) in the European Union, if BBVA deals on own account when executing client orders outside a regulated market, an MTF or an OTF established in the EU or recognised by the EU, in respect of the financial instruments listed in this document.

Notwithstanding the foregoing, when it is so requested by the client, BBVA in addition to its capacity as SI, may:

- deal in such financial instruments on own account; and/or
- execute orders on behalf of clients in respect of such financial instruments on a regulated market, an MTF, an OTF or over the counter.

For the purposes herein, "Traded on a Trading Venue" or "TOTV" means those financial instruments that are traded or admitted to trading in a regulated market, a multilateral trading facility (MTF) or an organised trading facility (OTF), established in the European Union.
