You are about to purchase a product that is not simple and may be difficult to understand.

1. What is this product?

The product has a fixed term and will be due on 29 February 2028, subject to an early redemption.

Objectives

The product is designed to provide a return in the form of (1) regular fixed interest payments and (2) a cash payment on termination of the product. The timing and amount of this payment will depend on the performance of the underlyings. The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the issuer may terminate the product early. These events are specified in the product terms and principally relate to the underlyings, the product and the

The stress scenario shows what you might get back in extreme market circumstances. 3. What happens if BBVA Global Markets B.V. is unable to pay out?

5. How long should I hold it and can I take money out early?

Recommended holding period: 3 years and 6 months

This Product will mature on 29 February 2028. This Product doesn't allow the Client to cancel his investment before 29 February 2028. However, under normal market conditions, BBVA may facilitate to the client the price at which BBVA is able to buy it. Such a price will be calculated subtracting (i) from the fair value of the Product calculated by BBVA in accordance to the market variables and methodologies commonly used in market (ii) an estimated cost of 1.5% over the Nominal Amount. This anticipated sale may generate a financial loss to the Client.
