Termination on the maturity date: If the product has not terminated early, on the maturity date you will receive:

- if the final reference level is at or above 689.4, a cash payment equal to GBP 1,000;

- if the final reference level is below 492.43, a cash payment directly linked to the performance of the underlying. The cash payment will equal (i) the product notional amount multiplied by (ii) (A) the final reference level divided by (B) 984.85.

5. How long should I hold it and can I take money out early?

Recommended holding period: 10 years

This Product will mature on 20 November 2035. This Product doesn't allow the Client to cancel their investment before 20 November 2035. However, under normal market conditions, BBVA may facilitate to the Client the price at which BBVA is able to buy the Product. Such a price will be calculated subtracting (i) from the fair value of the Product calculated by BBVA in accordance to the market variables and methodologies commonly used in market (ii) an estimated cost of 1.5% over the Nominal Amount. This anticipated sale may generate a financial loss to the Client.
