This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

FX Forward. This is an OTC derivative financial instrument, i.e. it is not traded on an exchange and, as such, it is arranged bilaterally between the client and BBVA. The client and BBVA agree to exchange two amounts denominated in two different currencies, on a specific date in the future (the "Settlement date").

Objectives

On the Settlement date, the client will pay BBVA an agreed amount of US Dollar (USD). In exchange, on the same settlement date, BBVA will pay the client an agreed amount of Romania Leu (RON). The relationship between both amounts is the forward rate in terms of units of Romania Leu (RON) for each Dólar estadounidense (USD).

The client seeks to benefit from future decreases in the value of Dólar estadounidense (USD) vs. Romania Leu (RON) in exchange for waiving the return from possible increases in its value.

In this document, the following have been considered: the forward rate is Romania Leu (RON) 4.762 for each Dólar estadounidense (USD), the amount paid by the client is US Dollar (USD) 2,100.079 and the amount paid by BBVA is Romania Leu (RON) 10,000.

The Settlement date matches the maturity date of the product and will occur until 3 months after the contract agreement date.

Intended retail investor

This product category is mainly designed for investors who:

- Investors with average knowledge of this financial product or with some experience in investing in this or similar products.
- Investors who are willing to accept losses not limited to the payment of a premium
- are able to hold the product until the 12/11/2022
- Investors whose aim is to achieve return and/or hedging linked to the progress of exchange rates

What are the risks and what could I get in return?

Summary Risk Indicator



The risk indicator assumes you keep the product for 3 months; until the date 12 November 2022. The actual risk can vary significantly if you cash in at an early stage and you may incur in significant losses. You may not be able to cash in early. You may have to pay a significant extra cost to cash in early.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is 7 the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact our capacity to pay you.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

What happens if BBVA is unable to pay out?

The customer would suffer a financial loss. In addition, this product is not covered by the Deposit Guarantee Fund for Financial Institutions or any other guarantee system or guarantor.

In the event of the resolution of BBVA (the process that would apply if BBVA were unviable or if it were foreseeable that it would become unviable in the near future and for reasons of public interest and financial stability it is necessary to avoid it going bankrupt), this product could be converted into shares or the payment obligations undertaken by BBVA to the customer could be reduced and the customer could therefore suffer losses.

What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the performance of the product. The total costs take into account one-off, ongoing and incidental costs

The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume a Nominal Value of 50,000 RON. The figures are estimates and may change in the future.

How long should I hold it and can I take money out early?

Recommended Holding Period: 3 months

The Product doesn't allow early termination or refund unless BBVA and the Client reach an agreement regarding the date and the early termination amount. In such case, the early termination amount at which BBVA is willing to terminate will be calculated in accordance with the "Market Value" criteria, which is, the result of terminating at present value the future rights and obligations expected for the Client and BBVA in accordance with the factors and valuation methodologies commonly employed in the market.

The previous result may imply a loss or benefit for the Client. Additionally, early termination will imply an implicit cost of 0.65% over the notional amount to terminate which (i) will increase the amount the Client must pay if said amount is negative or (ii) will reduce the amount the Client must receive if the Market Value is a positive amount.

If both parts agree to terminate the Product by means of the early exchange of the FX currencies previously agreed, the exchange rate will be determined by means of the market exchange rate adjusted by the Market Value of the Product and an implicit cost of 0.65% over the notional amount to terminate which will deteriorate the exchange rate for the client.
